

Procedures for the Sub-Committees

The Leisure Marine Association MENA (LMA) adopted these procedures to serve as a guide for the Sub-Committees' Representatives.

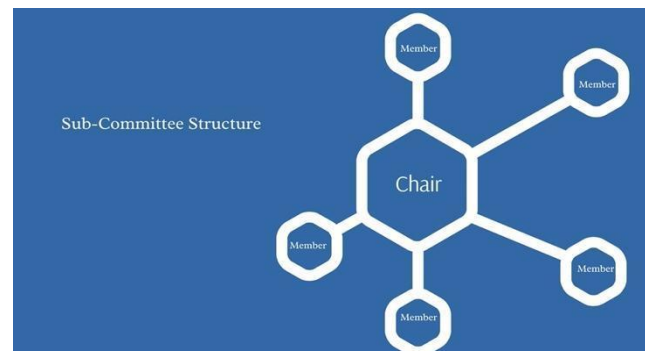
'**Sub-Committees**' are small groups of LMA members assigned to focus on a particular industry sector. Sub-Committees generally make recommendations to the LMA Board of Directors. It is an advisory role. Each member can indicate their interest in joining a particular Sub-Committee when applying for LMA membership. The following Sub-Committees are available to LMA members:

- Boat Finance & Insurance Sub-Committee - *chaired by: **Hamza Mustafa***
- Boat Manufacturer and Boat Repairs & Fit Out Sub-Committee - *chaired by: **Mrs. Abeer Alshaali***
- Brokers & Dealers Sub-Committee - *chaired by: **Mr. Sebastian Dumitrescu***
- Charter Sub-Committee - *chaired by: **Mr. Jonny Dodge and Mr. Michael Fetton***
- Provisions, Equipment & Accessories Supply Sub-Committee - *chaired by: **Mr. John W.R. Paul***
- Marketing & Communications Sub-Committee - *chaired by: **Mr. Wyndham Tops***
- Marina Sub-Committee - *chaired by: **Mr. Ahmed Abdelhalim***
- Membership & Sponsorship Sub-Committee - *chaired by: **Mrs. Carol Stoneman***
- Industry Report Sub-Committee - *chaired by: **Mr. Selcuk Balci***

'**Sub-Committee Chair**' a board member shall chair each sub-committee. Chairs will lead the Sub-Committee meetings, keep the minutes of the meetings, and present progress reports at monthly LMA Board meetings.

'**Membership of the Sub-Committee**' shall consist of an unlimited number of representatives. Sector-specific expertise shall be required of the representatives..

- Members of the LMA from within the sector shall fill casual vacancies in the Sub-Committee's representation.



'Sub-Committee Meeting' shall be held at least once a month but may be called at any time if urgent circumstances arise, and each Sub-Committee representative must attend. All meetings shall be held at a time and place convenient to the representatives.

'The Chair of the Sub-Committee' shall forward a copy of the Minutes of the Meeting (MOM) to the LMA Executive Manager within two days following each meeting. [The template for the MOM can be accessed here.](#)

'Responsibilities of Sub-Committees' should provide progress reports. In all relevant matters, shall make recommendations and resolutions to the LMA Board of Directors.

'Resignation' upon resigning from a Sub-Committee, the representative should write a letter to the Chair and LMA Executive Manager.

'Discharge' a motion may be moved by any representative in the meeting to discharge a member from a Sub-Committee if a member has not attended three or more consecutive meetings without the permission of the Chair.
