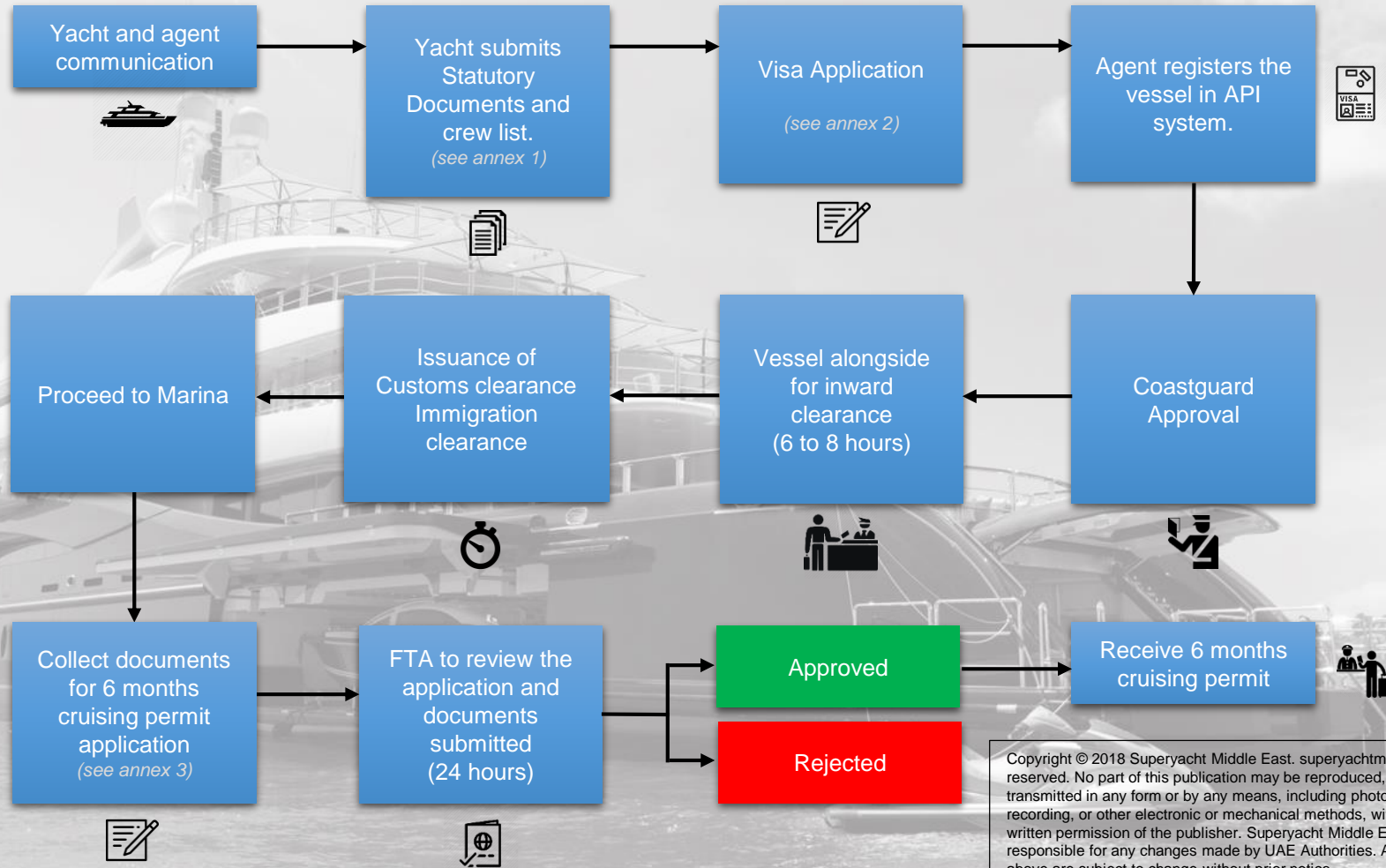

2. AIS powered and operational at all times.
3. Yacht registration under flag state.
4. Insurance covering third party liabilities.
5. Adhere to Federal and local regulations.
6. Report of any incident occurrence.
7. Copy of the Certificate of Class, Statutory Certificates, Sea Worthiness Certificate *(As applicable)*
8. Copy of the crew list and the passport copy of the crew and their visas
9. Copy of the appropriate crew qualification
10. Inward Clearance (1st Entry)
11. Agent trade license copy
12. NOL – Letter from agent or owner
13. Any other documents as per required by FTA
14. For acquiring the Jet Ski & Tender's Cruising Permit.
